### Instructions for giving consent via facsimile

1. Consent grantor must fill in the form correctly and completely and sign its signature.

Individual - copy of identification card which consent grantor must sign to certify true copy.
3. Consent grantor may send facsimile by itself or may assign any person to send on behalf of consent grantor.

### Condition for giving consent via facisile

Giving consent via facsimile is "electronic data" or is a clause which has been made, sent, received, kept, or processed by electronic method which consent grantor is prohibited to refuse the result, consequence, and enforcement by law of any clause just for the reason that such clause is in form of electronic data. Giving consent via facsimile, therefore, shall be deemed as giving consent according to the Credit Information Business Act in every respect.
